Lambeth Together Safeguarding Masterclasses

The Board is pleased to be part of another series of multi-agency masterclasses which have been developed to give Lambeth practitioners access to expert knowledge in challenging and complex safeguarding topics. An opportunity for joint learning, these sessions are open to all professionals working with children or adults at risk of abuse and neglect in Lambeth. Topics include Adult Family Violence, Serious Youth Violence, Consent and capacity in sex and relationship, safeguarding and homelessness and safeguarding in the digital age.

Resources and information

Over the past two years, the Board and it's subgroups have developed a range of resources to promote adult safeguarding and support professionals and service users. This has included;

Lambeth Single Point of Access

Lambeth has three Living Well Centres (LWC) which provide community support to adults with mental health needs. The LWCs have workers from South London and Maudsley NHS Foundation Trust (SLaM), social care and the voluntary sector who provide short term support and focused support teams. The service accepts new referrals for people not known to the Living Well Centres (LWC) and this can be done via the Single Point of Access. More information can be found here.

This initiative links to learning from SAR E, which highlighted the need for substance misuses services to have input and support from mainstream mental health services in order to offer a comprehensive assessment to the person.

Lambeth Homelessness and Rough Sleep Strategy

LB Lambeth's Homelessness and Rough Sleeping Strategy and Action Plan was renewed in 2019 and includes a number of targeted commitments which aim to improve the partnership working relationships between housing, health, and social care to ensure that matters can be dealt with promptly and successfully when they arise.

In reviewing this strategy, LBL Housing considered learning from SAR Yi; learning from this SAR has also led to Adult Social Care and Housing colleagues being provided with access to one another's recording systems to enable better information sharing and coordinated working in relation safeguarding concerns and assessments

Adult safeguarding work can be complex and demanding, and often requires staff to make urgent and sometimes difficult decisions whilst under pressure. Effective supervision is essential to support those practitioners responding to safeguarding concerns.

To support organisations to develop their own approach to supervision in the context of adult safeguarding, LSAB's Performance and Quality subgroup have developed some specific guidance. This framework is now available on the LSAB website.
